**TERMS AND CONDITIONS:**

**Membership**

1. Membership runs annually from 1 April - 31 March and continues automatically until cancelled in accordance with the resignation clause.
2. Membership fees are payable in advance on or before the 30th April subject to:
  - a) It is the prerogative of the Club to offer an early payment discount which may be available on request in which case fees are payable on or before the 1st April.
  - b) On application a member could be allowed to settle the subscriptions by monthly debit order, with the understanding that the member is liable for the full year's subscription fees.
3. These terms and conditions are subject to change at any given time by the Club
4. No variation of this agreement shall be of any force or effect unless such variation shall be reduced to writing and signed by both parties.
5. The Member will be entitled to utilise and access the facilities in accordance with his/her membership type, and rules/ regulations of the Club.
6. The Club may at any time withdraw all or part of the facilities for any period for reason of repair, alteration or refurbishment of the facilities, or for any reasons when the club deems it fit to do so.
7. The Member undertakes to ensure that all personal records, as held by the club pertaining to Membership, are up to date at all times.
8. Membership changes will only be allowed at the beginning of each new year, April, and has to be done in writing to the Golf Director, info@germistongolf.com

**Payments**

1. All Members will be subject to any annual increase in membership, handicapping and affiliation fees.
2. Should you encounter a problem making payments, please discuss your situation with the General Manager
3. Debit orders have to be renewed every new cycle.
4. Full Payments must be made into club's bank account, annually by the 30 April, please use your full name or membership number as reference.

**Resignations**

1. Membership can only be terminated by tendering to the Club ONE CALENDAR MONTHS WRITTEN NOTICE prior to the commencement of the new membership year, to info@germistongolf.com or hand delivered to the Golf Director.
2. Annual handicapping & affiliation fees are not refundable. If you are planning to resign from the Club kindly inform us by December. Prior notification of pending resignation received after 01 January, will result in the liability for the Handicap Card fees and Affiliation fees.
3. All debts must be settled when exiting the Club.
4. Members resignations received after the 01 April will be liable for the full year's subscription fees.

**Indemnity**

*Members acknowledge that GERMISTON GOLF CLUB and its committee are not liable for any loss, damage and/or injury sustained by any persons or property while on the premises, irrespective of whether such loss was occasioned by natural disasters, the negligence of GERMISTON GOLF CLUB, its employees, agents, representatives or anybody else, and Members indemnify GERMISTON GOLF CLUB in respect of any such claims.*

**Handicap Cards:**

1. The membership and/or the membership cards are not transferable to any other person/s under any circumstances.
2. Any lost or stolen cards must be reported to the golf manager immediately; a replacement card will be issued at a cost to the Member.
3. New applicants are liable for SAGA HNA and Affiliation fees, irrespective of the date joined.
4. SAGA HNA and Affiliation fees run from January to December, every year, and fees are payable accordingly.
